IT is hereby notified that the Minister of Health and Child Care, in terms of section 145 of the Health Professions Act [Chapter 27:19], has approved the following regulations made by the Health Professions Authority:—

- 1. These regulations may be cited as the Health Professions (Registration and Fees of Health Institutions) Regulations, 2017.
- 2. The fees payable for registration of an institution shall be as prescribed in the First Schedule.
 - 3. The annual fees shall be as prescribed in the Second Schedule.
- 4. The non-compliance fees for failure to comply shall be as prescribed in the Third Schedule.
- 5. The fees payable for registration of extension of services at a registered institution shall be as prescribed in the First Schedule.
- 6. The fees payable for miscellaneous issues shall be as prescribed in the Fourth Schedule.
- 7. The registration fees shall be payable as soon as Health Professions Authority receives the application paperwork from the respective Council.
- 8. Annual fees shall be payable by 31st January each year and failure to comply shall result in a late payment fee as prescribed in the Third Schedule.
- 9. Where an institution has been closed for failure to pay the annual fee, on making the application to be reopened, the institution shall pay a fee of an amount equal to—
 - (a) the opening closed premises fee prescribed in the Third Schedule:
 - (b) the current annual fee payable in terms of the Second Schedule multiplied by the number of years since the last annual fee paid.

10. When an institution has been closed in terms of Part XVIII of the Health Professions Act [Chapter 27:19], the non-compliance fees payable shall be as prescribed in the Third Schedule.
