

Collective Bargaining Agreement: National Employment Council
for the Insurance and Pensions Industry

IT is hereby notified that the Minister of Public Service, Labour and Social Welfare has, in terms of section 80(1) of the Labour Act [*Chapter 28:01*], approved the publication of the Collective Bargaining Agreement as set out in the Schedule.

The agreement was registered in terms of section 79 of the Labour Act [*Chapter 28:01*].

SCHEDULE

This agreement is made, in terms of the Labour Act [*Chapter 28:01*], between the Insurance Employers Association of Zimbabwe (IEAZ) (the employers association), on the one hand, and the Insurance Employees Union of Zimbabwe (ZIEU) (the trade union), on the other, being parties to the National Employment Council for the Insurance and Pensions Industry (NECIPI).

This supplementary agreement is made in terms of the principal agreement (Statutory Instrument 146 of 2016).

The details of the agreement are as follows:

1. That with effect from 1st July, 2021, to 30th September, 2021, companies/employers in the Insurance and Pensions Industry effect a 35.19% increase on basic minimum salary for grades A1 to C3 as per table below.
2. That with effect from 1st July, 2021, to 30th September, 2021, companies/employers in the Insurance and Pensions Industry paying above basic pay minimums (grades A1 to C3) effect a **10%** increase on the June, 2021, actual basic salaries.
3. That with effect from 1st July, 2021, to 30th September, 2021, companies/employers in the Insurance and Pensions Industry award a minimum housing allowance of \$6 500,00, per month for each NEC graded employee.
4. That with effect from 1st July, 2021, to 30th September, 2021, companies/employers in the Insurance and Pensions Industry award a minimum transport allowance of \$4 500,00, per month grossed up for tax purposes for each NEC graded employee.

5. That companies/employers who are able to pay more are encouraged to do so and to advise the NEC of such awards.
6. Companies/employers that are not able to comply with this CBA should apply for exemption to the NECIPI Exemption Committee within a month from the date of this agreement. Such applications should be accompanied by appropriate and relevant financial statements.
7. That companies/employers are reminded to remit NEC levies as required in terms of Statutory Instrument 146 of 2016.
