

Road Traffic (Axle-loading) (Amendment) Regulations, 2022 (No. 6)

IT is hereby notified that the Minister of Transport and Infrastructural Development has, in terms of section 81 of the Road Traffic Act [*Chapter 13:11*], as amended, the following regulations:—

1. These regulations may be cited as the Road Traffic (Axle Loading) (Amendment) Regulations, 2022 (No. 6).

2. The Road Traffic (Axle-loading) Regulations, 1993, published in Statutory Instrument 106 of 1993, as amended by Road Traffic (Axle-loading) (Amendment) Regulations, 2021 (No. 5), published in Statutory Instrument 251 of 2021, are hereby amended by the deletion of the Third Schedule and substitution of the following—

“THIRD SCHEDULE

FEEES

The fees for both locally registered vehicles and foreign registered vehicles are—

5. Period permits—

Period permits only apply to cranes, combine harvesters, cane haulers, buses and other similar vehicles.

6. The fees for foreign registered vehicles shall be payable in United States dollars or equivalent in other foreign currencies, using the above rates.
7. The fees stipulated above may be payable in local currency for locally registered vehicles at the prevailing interbank rate of the day.”.

3. The Road Traffic (Axle-loading) (Amendment) Regulations, 2021 (No. 5), published in Statutory Instrument 251 of 2021, are hereby repealed.
